

PARENT DRIVER Transportation Liability Waiver

(to and/or from Athletic Games/Extracurricular Events or Trips)

Students are required to travel on buses or by other District designated methods of transportation, for off-campus District sponsored activities, including, but not limited to practices, games, meetings, competitions, field trips and conferences ("Events"), and/or special circumstances with district administrator approval. Because this document serves as a special request and liability waiver, I agree that the District shall assume no Liability for injuries resulting from the following situations:

- Where I transport my son/daughter to or from an activity;
- Where I transport any other students to or from an activity;
- Where I, as a parent or guardian, give permission to another adult to transport my son/daughter home from an activity, and I have explained to the designated individual that s/he will assume all liability.

In consideration of my decision to decline District transportation, I hereby release and fully discharge and forever discharge the District, its officers, insurers, attorneys, agents, board members, employees, representatives, or other persons acting for or on behalf of the District, from any and all claims, compensations, costs, expenses, attorneys' fees, causes of action, damages (including, but not limited to punitive damages), demands, or causes of action, known or unknown, arising out of, resulting from or in conjunction with or relating to my son/daughter participating in this activity, but not including injuries that result from the negligence of school staff. I acknowledge that I have carefully read this permission form which contains a waiver of right to sue the District and understand its contents and consequences. I am signing this agreement knowingly and acknowledge that I have not relied on any representations, promises or agreement of any kind in connection with my decision to sign this document. This waiver does not waive any claims that cannot by law be released or waived.

I also agree that the Green Lake School District shall assume no liability whatsoever for injuries resulting from the above situations or any other situation where contracted or District owned transportation is not being used to transport students.

I have carefully read this release of liability and understand its contents. I am aware that by signing this release of liability, I am waiving certain legal rights, including the right to sue the District, its officers, insurers, attorneys, agents, board members, employees, representatives, or other persons acting for or on behalf of the District.
